3. Confirm the minutes of the September meeting:

4. Matters arising from the minutes

(a) Cllr Jean Lewis informed members that there were no updates in relation to a private matter at Talog.
(b) IW spoken to the Ambulance Liaison Officer in relation to the requirement for children pads. 5 batteries have been replaced. It was advised by Mark Gower not to replace the child's pads. All paediatric pads have been removed. It was also reported that the defibrillator at Abernant is leaking

(c) The Carmarthen sign by Pwlldyfarch needs to be replaced. Clerk to liaise again with the Council

(d) Potholes at Lon y Felin continue to be a problem. No update from Cllr Jean Lewis

(e) No update in relation to getting a quote for the website. The chairman will approach an appropriate web developer for advice and guidance

(f) Dog fouling bin at the crossroads in Abernant has been removed. Email received from Council stating that a condition survey has been undertaken on all current bins and their current locations will be prioritised on a desire to needs basis. Community Council's has been logged for future reference

(h) Talog bridge – a reply via email was received from the Council informing members that there is no immediate concern following some damage caused by a lorry following their on-site inspection. No further action to be taken by Carmarthenshire County Council

(i) There have been reports of people not being able to get broadband in Talog as the postcode is not identified. Further to another enquiry on broadband at Abernant, Cllr Jean Lewis will email the officer in the Council for assistance on broadband issues.

(j) A concern has been raised in relation to the development of a storage system on a piece of land which measures approximately 40 metres by 20 metres. No record of plans have been submitted to the Council. Council Officer attended the site and taken photographs.
